LOCAL RULES

- MOTOR CARTS MUST REMAIN ON CART PATH ON ALL PAR 3'S AND 30 FT. FROM GREENS ON ALL PAR 4'S.
- NO PRIVATE COOLERS ARE PERMITTED.
- GOLFER IS RESPONSIBLE FOR ANY DAMAGES TO CART OR PROPERTY.
- USGA rules govern all play.
- Distance on tee box markers are to the center of the green.
- Rake all bunkers - Repair all ball marks - Replace all divots.
- Red stakes define lateral water hazards.
- Yellow stakes define water hazards.
- White stakes define out-of-bounds.
- Proper golf attire required.
 - No tank tops & no cut-off shirts.
 - Shirts must be worn at all times.

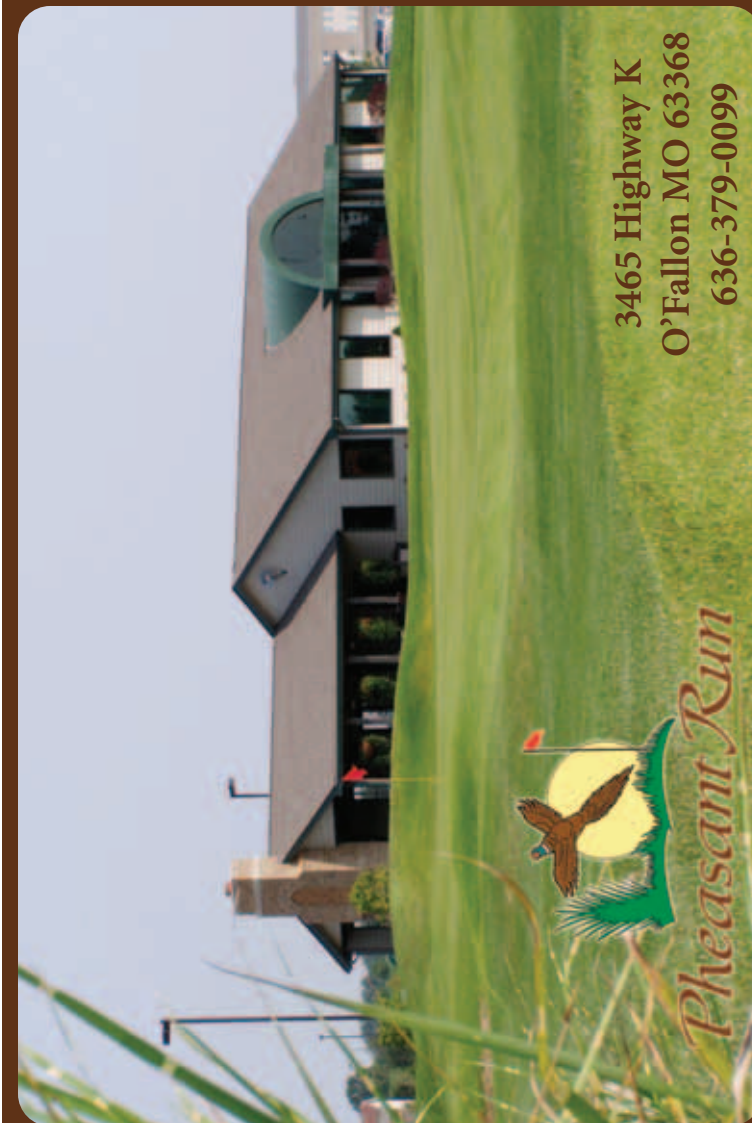
